A. Treasurer

Report given by Jean Galbraith in Don's absence

#### **Financial Status**

The Treasurer's handoff has been completed and I have been added as a signing officer for the FVSRDA HSBC Accounts (Operating, Valley Circle and DeSmit). Changes have not been made to the Vancity account where the FVSRDA term deposits are held. No changes are required on the term deposits until next summer. Although the formal handoff has occurred, the knowledge transfer still has a long way to go. Mary Cox has been very helpful during the transition and I am sure I will have to check with her many more times in the future.

Handed out at the meeting, Balance Sheet, Income Statement and Reconciliation Report. The Reconciliation Report relates to the September 30, 2016 bank statements. The Balance Sheet and Income Statement reflect all transactions up to October 14, 2016. The balance for the DeSmit account should be \$500.00 lower than it is and the balance for the Operating Account should be \$500.00 higher than it is on the statements. The difference occurred since the Promotion Committee grant was taken from the Operating Account when it should have come from the DeSmit account. Money will be transferred to correct the problem once I get the necessary signatures.

The Canadian Society AGM was held on the Saturday morning with most Provinces in attendance and reporting. Full details on the CSRDS Webpage.

The Society asked if we, B.C., could look into holding a CSRDS Festival in 2020 since it will then be 20 years since we held our last Festival. The CSRDS will give us a Grant of \$5,000.00 to start with. Steve Edlund along with Annette and Norm & Mary Cox have looked into the possibility of holding it at the Guildford Sheraton Hotel. The Hotel has several rooms that would give sufficient space for such a Festival and they have very good accommodation. We are working to get prices at the moment. The flooring will be our biggest problem.

## J. Festival 2017

**Dave McVige Written** report submitted by Wendy Krueger Read by Jean Galbraith in Dave's absence There are about 140 people registered for the festival, including 15 callers and cuers.

The winner of the free registration is Chuck Sheehan! Congratulations to Chuck!

The registration cost has gone up to \$45 per person (\$25 for youth). After March 1, 2017, it goes up to \$50 per person (\$30 for youth). Everyone is encouraged to register as early as possible.

More information is being added to the website as it becomes available. Take note if you want to book rooms at the nearest hotel: it is the Holiday Inn located at 64<sup>th</sup> Ave and 176<sup>th</sup> Street– very close to our venue – rooms need to be booked before May 18<sup>th</sup>, 2017 to get in on the special rates. They have a 14 day cancelation policy.

- Dogwood Campground and Tynehead RV Park are listed on the Festival website they will take registrations as early as this month
- Dry Camping (with electricity) onsite is a 10 minute walk from the halls. We will have a 6 or 8 seater golf cart shuttle for campers. Note that if you want to camp together, you need to arrive together. Handicapped spots will be closer to washrooms. Please let Betty and George Langtry know if you need to camp in the H/C spots.

Hopefully local dignitaries will accept our invitation to attend our opening ceremonies.

Ad space in our Festival booklet will be for sale to local businesses.

The Chilliwack Décor Team is planning all the Festival decorating. Shannon Hall will be decorated with sunrise as a theme and the Alice McKay building will sport the sunset theme.

Publicity chair couple Alex and Jean Galbraith are getting the word out to as many individuals and square dance organizations as possible, and are asking for the help of all registered dancers to spread the work, invite people, wear your ribbon that says you are registered. Clubs are asked to keep the Festival poster in sight and keep a few registration forms on hand. Registration on line is open and proving to be quite popular. There is a fee from our financial services provider for this service and it is added to the registration total when you pay on line. It is requested that club announcements include mention of the Festival frequently, i.e. weekly. Callers and cuers are asked to register for the Festival and talk it up at your dances. A 2-foot by 4-foot banner was purchased and it was taken to various events over the summer, including the National Convention, Chase the Fun, and Circle 8 Ranch in WA State. Committee members can bring the banner to clubs to display on a club night or at a special dance.

#### **New Business**

#### A. New Society Act – Blair Wallace

As requested by the FVS&RDA Executive, I have reviewed the information provided by Peter Tamilin with respect to the required transition to BC's new Societies Act.

Basically what is happening in the BC Government has re-written the Societies Act to bring it up-to-date. The BIG change will be in reporting – all will be done on-line.

It's easier than you may think. "Transitioning" requires a society to re-file, in electronic format, its current constitution and bylaws with the Corporate Registry. A few changes to the content of the constitution and bylaws may be required, as will be discussed below.

Societies cannot transition until the new Act comes into effect on Nov. 28, 2016. They will then have two years, until Nov. 28, 2018, to file their Transition Application. The Transition Application will be an online form provided by the Corporate Registry – paper filings will not be allowed.

To get ready for the transition we need to have a look at the Association's Constitution and Bylaws. We also need to make a decision with respect to whether the Association is "Member Funded".

## **Closure:**

Transition must be complete by November 28, 2018

To Transition, a Society must file a transition application consisting of its revised constitution, consolidated (or completely new) bylaws, and statement of directors and registered office.

#### I recommend:

- a) We consider a Special Resolution to become a Member Funded Society at the AGM.
- b) We strike a small committee (3 people) to review the current bylaws and recommend changes for the consideration of the members at the AGM. The committee would also prepare the necessary edits for the Resource Binder related to the transition and related matters (i.e. the documentation). The committee can meet electronically (i.e. exchange drafts by email). All documents to be ready by March 1, 2017 so that they can be circulated to all members for consideration.
- c) We file the changes to the directors as needed following the AGM.
- d) We transition to the new Societies Act following the AGM.

Report to be brought to the next General Meeting.

To All Clubs:

The BC Government is transitioning from the Society Act to the Societies Act starting on November 28, 2016. This is important if your club is a registered society in BC. The steps clubs need to follow are as follows:

- 1) Determine if your club is a registered society. You can know this if your club receives an annual bill from the Government for society fees. If you club does, proceed to 2). If no, you are done.
- 2) Collect together a copy of you constitution and bylaws. If you can't locate a complete up-to-date copy, they can be obtained from the BC Government.
- 3) Review your constitution and bylaws against the requirements of the new act. - 4) Begin the transition process. The process will likely require changes to your constitution and bylaws which would need to be made at a general meeting or annual general meeting of your club through special resolutions. The transition must be complete by November 28, 2018.

If your club IS a registered society and you do not choose to transition, your club will be deregistered as a society. The club must consider the pros and cons of such a decision.

#### C. Festival 2020 Norm Cox

MOTION – Moved by Norm Cox and seconded by Ron Robertson that the F.V.S. & R.D.A in co-operation with the V. & D. Caller/Teachers Association and with the blessing of the B.C.S.&R.D. Federation seek input and gather information as to the feasibility of holding a CSRDS National Festival in the Lower Mainland in July 2020.

Since this time I have been gathering information so I have an amendment to the original motion made at the fvs&rda Executive Meeting on October 15<sup>th</sup> 2016

#### **MEMORANDUM**

**Re:** Transition to the New BC Societies Act

All,

As requested by the FVS&RDA Executive, I have reviewed the information provided by Peter Tamilin with respect to the required transition to BC's new Societies Act.

Basically what is happening in the BC Government has re-written the Societies Act to bring it up-to-date. The BIG change will be in reporting – all will be done on-line.

It's easier than you may think. "Transitioning" requires a society to re-file, in electronic format, its current constitution and bylaws with the Corporate Registry. A few changes to the content of the constitution and bylaws may be required, as will be discussed below.

Societies cannot transition until the new Act comes into effect on Nov. 28, 2016. They will then have two years, until Nov. 28, 2018, to file their Transition Application. The Transition Application will be an online form provided by the Corporate Registry – paper filings will not be allowed.

To get ready for the transition we need to have a look at the Association's Constitution and Bylaws. We also need to make a decision with respect to whether the Association is "Member Funded".

So, first things first:

#### Are we a Member Funded Society?

On reading the Transition Documents that Peter provided, there is one important decision that must be made before we transition to the new Societies Act. The decision is whether the FVS&RDA wants to be a Member Funded Society or not.

Member-funded societies are funded primarily by their own members to carry on activities for the benefit of those members. A society cannot be a member-funded society if it receives significant public donations or government funding or is a type of society that is specifically not allowed to be a member-funded society under the Act or the regulations. Member Funded Societies are subject to fewer disclosure and accountability measures than other societies.

#### BUT,

Member Funded Societies are not eligible for Gaming Grants from the Ministry of Community, Sport and Cultural Development. As I read the rules, the FVS&RDA would not be the eligibility for such grants (see: <a href="http://www2.gov.bc.ca/assets/gov/sports-recreation-arts-and-culture/gambling/grants/guide-cgg.pdf">http://www2.gov.bc.ca/assets/gov/sports-recreation-arts-and-culture/gambling/grants/guide-cgg.pdf</a>) anyway as we:

- Do not "primarily operate for community benefit"; or,
- Do not "provide programs that benefit the community and not solely its members' interest".

As required by Section 3.1 of the eligibility for grants.

If we want to become a Member Funded Society, we must pass a "Special Resolution" before we transition. The Special Resolution would require 75% approval in accordance with the current bylaws.

I recommend that at the Annual General Meeting of the FVS&RDA a Special Resolution as follows be presented for the member's consideration:

"It is herewith moved that on transition to British Columbia's new Societies Act, that the Fraser Valley Square and Round Dance Association become a Member Funded Society"

#### The Constitution:

The FVS&RDA Constitution as it presently stands is consistent with the requirements of the new Societies Act. As a result, no changes are needed.

## The Bylaws:

The FVS&RDA Bylaws as they presently stand are consistent with the requirements of the new Societies Act. We have always filed consolidated copies, so no "consolidation" is required. We are very lucky. Currently, the bylaws place no restrictions on the availability of records to members, there is no proxy voting, etc.

BUT it may be the opportunity to have a good look at the bylaws and make updates / changes. I have taken the opportunity to go through the current bylaws and have a number of suggestions for minor changes. For example, Section 2.1 of the bylaws reads:

2.1 Membership in the Fraser Valley Square and Round Dance Association shall be available to any club whose leader is a member in good standing with their recognized association. (Refer to 1.1(I))

## 1.1 (I) reads:

(I) "Caller" shall mean any leader who is a member in good standing with their recognized association, as determined by the Fraser Valley Square and Round Dance Association.

As I read these sections, a club without a caller cannot be a member of the Association. Further, a club whose caller is not a member of the V&DCTA cannot be a member. Requiring a club to have a caller and requiring that caller to be in good standing with a separate organization is not logical. This should be fixed.

# When can bylaw changes be made?

Societies will have several opportunities to amend their bylaws (or replace them entirely) in order to remove inconsistencies, impose restrictions and provide authorizations. Here are the options:

- 1. Amend bylaws before new Act comes into force (before Nov. 28, 2016)
  - requires special resolution 3/4 vote
  - requires separate filing of special resolution (under current Society Act) and \$50 fee

**Note:** Once the new Act comes into force on Nov. 28, 2016, a society will be unable to amend its bylaws until it transitions.

- 2. Amend bylaws on transition (on or after Nov. 28, 2016)
  - requires special resolution 2/3 vote (unless higher threshold expressly set out in bylaws) or 3/4 vote if special resolution was passed before Nov. 28, 2016
  - can be done as part of the Transition Application no separate filing or fee is involved
- 3. Amend bylaws after transition
  - requires special resolution 2/3 vote (unless higher threshold expressly set out in bylaws)
  - · requires separate filing (bylaw alteration application) and \$50 fee

#### **Statement of Directors and Registered Office:**

We need to make sure that the current filings for the list of directors and the address for the registered office of the Association are up-to-date. As some names will change at the AGM, this can be done then.

#### **Registered Office:**

The Registered Office of the Association under the current bylaws is the Treasurer's address. We need to add the following information to the Resource Binder an insure that these records are kept and maintained:

A society must keep the following records:

a. the society's certificate of incorporation;

- b. each certified copy, furnished to the society by the registrar, of the following records:
  - i. the constitution of the society;
  - ii. the bylaws of the society;
  - iii. the statement of directors and registered office of the society;
- c. each confirmation, other certificate or certified copy of a record furnished to the society by the registrar, other than in response to a request;
- d. a copy of each order made in respect of the society by any court or tribunal, in Canada or elsewhere, or a federal, provincial or municipal government body, agency or official, including the registrar;
- e. the society's register of directors, including contact information provided by each director;
- f. each written Consent to Act as Director referred to in section 42 (4) (a) [designation, election and appointment of directors] and each written resignation of a director;
- g. a copy of each record described in section 56 (3) (c) [disclosure of director's interest] or 62
   (3) (c) [disclosure of senior manager's interest] evidencing a disclosure by a director or senior manager;
- h. the society's register of members, organized by different classes of member if different classes exist, including contact information provided by each member;
- i. the minutes of each meeting of members, including the text of each resolution passed at the meeting;
- j. a copy of each ordinary resolution or special resolution, other than a resolution included in the minutes referred to in paragraph (i), and, in the case of a resolution consented to in writing by the voting members, a copy of each of the consents to that resolution;
- k. the financial statements of the society required under section 35 [financial statements] and the auditor's report, if any, on those financial statements.

#### **Closure:**

Transition must be complete by November 28, 2018

To Transition, a Society must file a transition application consisting of its revised constitution, consolidated (or completely new) bylaws, and statement of directors and registered office.

#### I recommend:

- e) We consider a Special Resolution to become a Member Funded Society at the AGM.
- f) We strike a small committee (3 people) to review the current bylaws and recommend changes for the consideration of the members at the AGM. The committee would also prepare the necessary edits for the Resource Binder related to the transition and related matters (i.e. the documentation). The committee can meet electronically (i.e. exchange drafts by email). All documents to be ready by March 1, 2017 so that they can be circulated to all members for consideration.
- g) We file the changes to the directors as needed following the AGM.
- h) We transition to the new Societies Act following the AGM.

#### SOCIETIES ACT (BRITISH COLUMBIA)

#### Persons qualified to be directors

- 44 (1) A person is qualified to be a director of a society only if the person is an individual who is at least 18 years of age.
  - (2) Despite subsection (1), an individual who is 16 or 17 years of age is qualified to be a director of a society if provided for in the regulations.
  - (3) Despite subsections (1) and (2), an individual is not qualified to be a director of a society if the individual is
    - (a) found by any court, in Canada or elsewhere, to be incapable of managing the individual's own affairs,
    - (b) an undischarged bankrupt, or
    - (c) convicted in or out of British Columbia of an offence in connection with the promotion, formation or management of a corporation or unincorporated entity, or of an offence involving fraud, unless
      - (i) the court orders otherwise,
      - (ii) 5 years have elapsed since the last to occur of
        - (A) the expiration of the period set for suspension of the passing of sentence without a sentence having been passed,
        - (B) the imposition of a fine,
        - (C) the conclusion of the term of any imprisonment, and
        - (D) the conclusion of the term of any probation imposed, or
      - (iii) a pardon was granted or issued, or a record suspension was ordered, under the Criminal Records Act (Canada) and the pardon or record suspension, as the case may be, has not been revoked or ceased to have effect.
